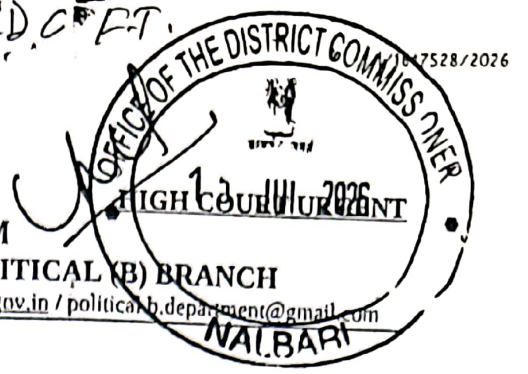

OFFICE MEMORANDUM

Subject : *Term & Condition for appointment of Assistant Government Pleader at Foreigner's Tribunals, Assam.*

On the matter of appointment of Assistant Government Pleader in Foreigner's Tribunal in Assam to assist the Member, Foreigner's Tribunal in various cases for detection of illegal migrants in force of the following guidelines and credential are enacted to follow in the process of appointment of Assistant Government Pleader in Foreigner's Tribunals in Assam.

1. The applicant must be an Indian Citizen as defined under Clause (5) of Indian Constitution.
2. The applicant must possess a degree in law from the Government recognized University and be a member of Bar Council / District Bar Council.
3. The applicant must have 7 (seven) years' experience as Advocate/Pleader.
4. The minimum age for engagement as Assistant Government Pleader at various Foreigners Tribunals in Assam is 35 years.
5. The tenure of Assistant Government Pleader shall be of 2 (two) years at a time and renewable only after satisfactory performance and in consultation with concerned Member, Foreigners Tribunals.
6. All applications for appointment as Assistant Government Pleader in Foreigners Tribunals must be routed through the D. C. concerned of the district to the Government.
7. On receipt of application for the Post of Assistant Government Pleader the D. C. concerned will recommend the application only in consultation with the concerned Member, Foreigners Tribunals.
8. The concerned D.C. would examine qualification, performance in local court etc. of such applicant who applies for the post of Assistant Government Pleader. The D. C. may not recommend application to the government, if he does not find the applicant fit for the post.
9. On receipt of such application from the concerned D. C., Political (B) Department will consider their candidature for the post of Assistant Government Pleader in consultation with Judicial Department.
10. The rate of retaining fee, daily fee and adjournment fee of the Assistant Government Pleader will be regulated as per Government Notification No. PLB.41/2000/Pt/95 dated 27/06/2013.
11. After appointment, the Assistant Pleader is debarred from appearing against the State of Assam during the term of his/her retainer.

All Members, Foreigner's Tribunals, Assam are to adhere to the above provision while submitting the proposal for Assistant Government Pleader to the Government. This Office Memorandum will come into force with immediate effect.

This has the approval of Judicial Department and Finance (EC-II) Department vide their U/O No.404/15 dated 24/07/2015 and 1248/2015 dated 09/11/2015 respectively.
