Minutes of the District Development Committee (DDC) Meeting for the month of February, 2022 held on 08-02-2022 at 11.00 A.M. in the Conference Hall Deputy Commissioner's office, Nalbari.

Members present – As per Annexure – 'A'.

The District Development Committee meeting was presided over by Smti Gitimoni Phukan, ACS Deputy Commissioner, Nalbari who welcomed all Head of Development Departments present.

She then requested the DDC to continue the meeting with discussion on the updated reports submitted by Departments on the Actionable Points and Monitorable target.

A power point presentation on the updated follow up action the departments against the Actionable points and Monitorable targets was given and after discussion the following instructions to the concerned departments were given.
