Minutes of the District Development Committee (DDC) Meeting for the month of June, 2022 held on 07-06-2022 at 11.00 A.M. in the Conference Hall of Deputy Commissioner's office, Nalbari.

The District Development Committee meeting was presided by Smti Gitimoni Phukan, ACS Deputy Commissioner, Nalbari and welcomed all Head of Development Departments present in the meeting.

At the very outset the Deputy Commissioner, Nalbari urged the departments to ensure achieve the of target as assigned in the DC's conference held on 23rd and 24th August, 2021 as DC's conference fixed on 12th and 13th June, 2022 at Tezpur.

Then the meeting was started with a Power Point Presentation on the Action Points and Monitorable targets in connection with DC's conference held on 23rd and 24th August, 2021. The Hon'ble Minister, P&RD told the CEO, ZP and BDOs to verify the schemes as 117% mandays generated in the FY-2021-22 in the district. He also emphasized that schemes should include permanent nature of assets under MGNREGA in Action Plan for FY-2022-23.

The BDO, Barkhetri to assured to complete the remaining PMAY (G) houses by Aug, 2022. In this connection all BDOs were instructed to complete 43 houses per day to achieve the target in 90 days. The Hon'ble Minister also requested the District Administration to provide land to 8 no. landless PMAY (G) beneficiaries.

(d) 15th Fin Commission grant: The Hon'ble Minister, P&RD instructed all BDOs to hold the BLVMC and DPC meeting for approval of schemes under Tied and Untied Fund under the programme. He also instructed the EE, PHE, Nalbari & Belsor to handover the completed PWSS to the Gaon Panchayat immediately for proper maintenance.

Public Health and Engineering: The EE, PHE, both presented the PPT of progress of work.

(a) <u>STATUS OF FUNCTIONAL HOUSEHOLD TAP CONNECTION UNDER JJM</u>

- Total Households in the District = 168004
- Total Household covered with FHTC till May /2022 = 69284
- Balance Households to be covered = 98720
- Household to be covered from already approved Schemes = 28426
- Nos. of Household for which new Proposal has been submitted (99 Nos + 84 Nos. =183 Nos) = 34026
- Nos. of Household for which proposals to be submitted = 35153
- Nos. of Households in riverine Areas for which Proposals are to be submitted =14243
- Nos. of Households in General Areas for which Proposals are to be submitted = 20910
- The target for FY 2021-22 is 47524 nos. and achievement is 48340 nos. (101.72%)

The E.E. PHE both are instructed to complete the mega PWSS schemes by June, 2022 enable for inauguration by Hon'ble Chief Minister. Further they are also instructed to check the quality of water, pipe leakage and quantity of water provided through FHTC.

(b) IHHL: The Hon'ble Minister, P&RD, PHE and FCS&CA has raised concern on requirement of IHHL in the district. He instructed the EE, PHE both to verify properly through competent officer, if any discrepancies done by the NGOs.

Food Civil Supplies and Consumer Affairs: The DDS I/c, FCS&CA has intimated that due to slow procurement of paddy by FCI, NACOF achievement is 9957 MT out of 29,000 MT. The Hon'ble minister has instructed the Deputy Commissioner to submit proposal to the Govt. for setting up 2 more PPC under AFCSCL.

Then Hon'ble Minister, Panchayat and Rural Development, PHE, FCS & CA and GAD, Assam has thanked all the HoDs for their cooperation in the meeting and also urged to give their level best for completion of Govt. schemes in time for betterment of the general public.

Thus the meeting ended with the vote of thanks from the Chair.
